Pursuant to the Commission's *Interim Guidelines Regarding Notification by an Electric Generation Supplier of Operational Changes Affecting Customer Service and Contracts*, adopted on August 13, 1998 in Docket No. M-00960890F.0013, the purpose of this joint letter is to advise the Pennsylvania Public Utility Commission ("PUC" or "Commission") that [REDACTED] and Energy Plus Holdings LLC ("Energy Plus") have entered into an asset purchase agreement (the "Agreement") for the acquisition by Energy Plus of certain [REDACTED] retail electric supply customer accounts of [REDACTED] in the Commonwealth of Pennsylvania. Specifically, [REDACTED] has assigned to Energy Plus approximately [REDACTED] contracts for the provision of electric generation services to Pennsylvania retail customers. [REDACTED] Electric Generation Supplier (EGS) license number is [REDACTED] Energy Plus' license number is A-2009-213745.

As required by the *Interim Guidelines*, a 30-day notice is being sent to the impacted customers to inform them of the contract transfer. This notice includes the following information:

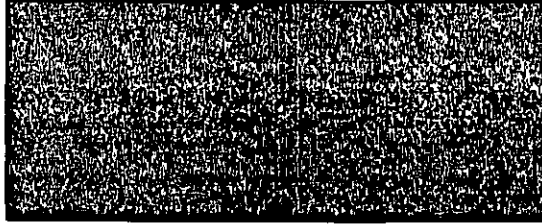
- The transfer of service from [REDACTED] to Energy Plus will be initiated after the expiration of the 30 day notice period and that the effective date of the transfer is expected to occur as of the meter read date after April 22, 2013.
