MOTION FOR CONTINUANCE OF HEARING DATE

PECO Energy Company ("PECO Energy"), pursuant to 52 Pa. Code § 1.15(b), hereby requests a continuance of the hearing date scheduled in this matter and states the following:

1. An initial in-person hearing on this matter is currently scheduled for Tuesday, March 19 at 1:30 p.m.
2. The formal complaint that will be litigated at the hearing raises issues regarding high bills at the Complainant's residence located at 331 Flower Street, Chester, PA 19013.
3. Specifically, the Complainant states in her formal complaint "I do not use that much electric monthly."
4. To address the Complainant's formal complaint, PECO Energy has scheduled a high bill field investigation at the Complainant's residence.
5. The first available date for a high bill field investigation is on March 29, 2013.
6. PECO Energy has scheduled a high bill field investigation to take place on that date.
7. PECO Energy plans to submit a report of the investigation results at the time of the hearing.
8. As the high bill field investigation is scheduled to take place ten (10) days after the hearing, PECO Energy is requesting a continuance of the March 19, 2013 hearing.

9. PECO Energy respectfully requests a hearing date to be scheduled shortly after the March 29, 2013 high bill field investigation.

10. PECO Energy has contacted the Complainant, Robin Hall, and she has indicated that she has no objection to PECO Energy's request for a continuance.

11. PECO Energy therefore respectfully requests that the hearing be continued to a further date.
