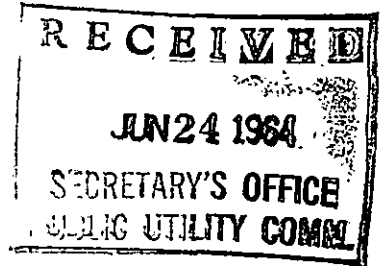

Under the circumstances, no coverage existed under the Washington General Insurance Policy and we feel that we have no alternative but to cancel policy and Pa. P.U.C. from inception, May 1, 1964 and attach Form UCPC-33 indicating said cancellation.

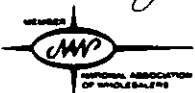
Dear Mr. Nye,

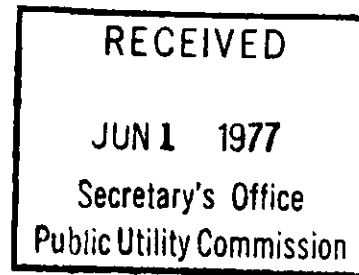

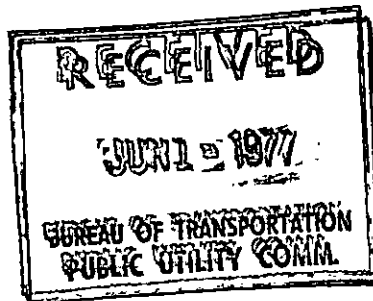
