





To Whom it May Concern:

This is in response to your assessment invoice in which you indicated a change in entity. If the change in entity is accompanied by a change in ownership, such as addition of new members or stockholders, then you must file a new application. Otherwise, you must file a verified letter as described below. Enclosed is a sample copy of a verification statement.

In order to make the requested changes, you must comply with provisions of Title 52 § 3.381(a)(7)(ii)(A), which requires that you submit a verified letter of notification to the Secretary containing the following information:

- The docket number of the motor carrier and the name of the motor carrier as presently shown in Commission's records.
- A copy of the articles of incorporation
- The names of the owners of the stock and the distribution of shares
- The names of the officers or directors of the corporation
- A statement that there has been no change in the ownership or control of the company

Upon submission of the above items, the Commission will endorse the existing certificate in the name of the new entity at the existing docket number. In accordance with Title 52 § 3.381(a)(7)(ii)(B), within thirty (30) days of the Commission's endorsement, the motor carrier shall effect the change in entity on its insurance filings (Form E and Form H or cargo waiver if applicable) with the Commission.
