

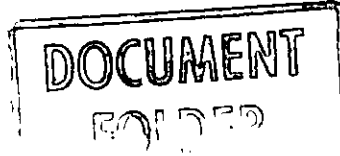

We enclose for filing with the Commission the original and two copies of the application of C. D. Ambrosia Trucking Co. for approval of the transfer of the operating rights held by Truckway Service, Inc. To each copy of the application there are attached copies of the Agreement of Sale, as well as other pertinent exhibits and appendices.

This transaction is related to a purchase by C. D. Ambrosia Trucking Co. of interstate operating authority which was approved by the Interstate Commerce Commission at Docket No. MC-F-19519 on November 8, 1989. 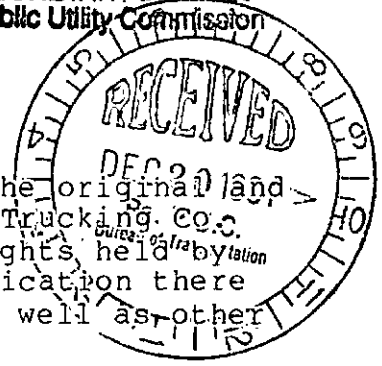
