
Dear Secretary Chiavetta:

On January 31, 2013, Peoples TWP, LLC (“Peoples TWP” or the “Company”) filed the “Petition of Peoples TWP, LLC for Approval of a Distribution System Improvement Charge” (“Petition”) with the Pennsylvania Public Utility Commission (“Commission”) at the above-referenced docket. The filing included a proposed pro forma tariff implementing a Distribution System Improvement Charge (“DSIC”), as well as testimony from two witnesses. Peoples TWP requested that the DSIC become effective on April 1, 2013.

In Peoples TWP’s filing, and as required by statute, the Company stated that it would provide an updated DSIC rate ten days prior to the effective date of the DSIC. The updated DSIC rate, per the effective date requested in the Petition, would be due today, March 22, 2013. However, because Peoples TWP’s Petition has not been approved by the Commission, and no public meeting dates are scheduled prior to the requested effective date, Peoples TWP’s DSIC cannot become effective on April 1, as requested. Therefore, Peoples TWP is delaying filing its updated DSIC rate at this time.
