



Enclosed is the compliance order issued by the Commission in this proceeding.

A certificate of public convenience evidencing the Commission's approval of the right to operate will not be issued until the applicant has complied with the following insurance and tariff requirements.

- I. Arrange through an insurance agent to have an insurance company file the following forms with the Commission.
 - a. A Form E as evidence of minimum public liability and property damage insurance coverage as shown on the enclosed sheet.
 - b. A Form UCPC-31 as evidence of cargo insurance coverage in an amount not less than \$2,500 per vehicle. Under certain circumstances, exemption from the cargo insurance requirements may be secured by filing the enclosed Form PUC-288.
- II. Prepare and file a tariff according to the enclosed instructions.

No motor carrier operating without complying with the above requirements will be subject to the penalty provisions of the Public Utility Law.

ORDER


BY THE COMMISSION:

By application docketed April 9, 1985, Thomas X. Liebtag, t/d/b/a Lee's Moving and Storage, seeks approval of the transfer to him of all the rights granted to Richard S. Hasson, t/d/b/a Juniata Moving & Storage Company, under the certificate issued at A-00094727.

We find the applicant to be fit to hold a certificate of public convenience and that approval of the application is necessary and proper for the continuation of service to the public; THEREFORE,

IT IS ORDERED: That the application for the transfer of rights held by Richard S. Hasson, t/d/b/a Juniata Moving & Storage Company at A-00094727 be approved and that a certificate be issued to the applicant granting the following rights:

- To transport, as a Class D carrier, household goods and office furnishings, new or used, and household goods and office furnishings, in use, between points in the city and county of Philadelphia.
- 2. To transport, as a Class D carrier, household goods and office furnishings, new or used, and household goods and office furnishings, in use, from points in the city and county of Philadelphia to other points within an airline distance of twenty-five (25) statute miles of the Philadelphia City Hall, and vice versa;





subject to the following conditions: That the approval hereby given is not to be understood as committing the Commission, in any proceedings that may be brought before it for any purpose, to fix a valuation on the property and rights to be acquired by applicant from the present certificate holder equal to the consideration to be paid therefor, or equal to any value that may be placed thereon by applicant, or to approve or prescribe rates sufficient to yield a return thereon. That applicant shall not record in his utility accounts any amount representing the rights herein granted in excess of the actual cost of such rights to the original holder thereof. That the accounts of the transferee shall reflect the same book values as the records of the transferor at the effective date of the transfer, any previously recorded appreciation having been deleted therefrom; provided that the applicant shall not record in his utility accounts any amounts representing the rights herein granted in excess of the actual cost of such rights to the original holder thereof. 4. That the operating authority granted herein, or now held or subsequently granted to the applicant to the extent that it is duplicative shall not be construed as conferring more than one operating right. That the certificate holder shall comply with all of the provisions of the Public Utility Law as now existing or as may hereafter be amended, and Pa. Code Title 52, Chapter 31, as now existing or as may hereafter be amended, and any other rules and regulations as may hereafter be prescribed by the Commission. Failure to comply shall be sufficient cause to suspend, revoke or rescind the rights and privileges conferred by the certificate. IT IS FURTHER ORDERED: That the applicant shall not engage in any transportation granted herein until he has complied with the requirements of the Pennsylvania Public Utility Law and the rules and regulations of this Commission relative to the filing and acceptance of evidence of insurance and a tariff establishing just and reasonable rates. - 2 -

That in the event said applicant has not, on or before sixty (60) days from the date of the service of this order, complied with the requirements hereinbefore set forth, the application shall be dismissed without further proceedings. IT IS FURTHER ORDERED: That upon compliance with this order the rights granted the transferor Richard S. Hasson, t/d/b/a Juniata Moving & Storage Company at A-00094727 be cancelled and the record be marked closed. BY THE COMMISSION,
