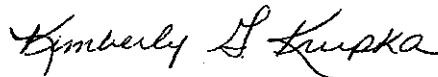

**CERTIFICATE OF SATISFACTION**

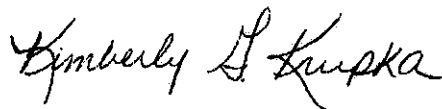
1. Complainant is Ahayah's Mini Mart.

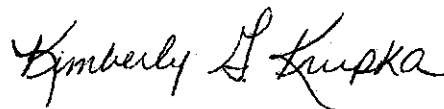
