
On behalf of the employer Young's Environmental Cleanup, Inc. (Young's), I am submitting this letter to request that the order dated March 14, 2013 be rescinded.

Young's Environmental has been in continuous contact with enforcement officers of the Commission since its initial audit on April 18, 2012. Throughout communication Young's was informed that pending discrepancies in reports following the second Safety Fitness Review it would be granted a third opportunity. Per direction of the PUC, Young's has already scheduled the third Safety Fitness Review for April 9, 2013. Upon the notification we received stating that we were in fact granted the third opportunity, we were informed that the Bureau of Investigation & Enforcement was going to withdraw the complaint filed against Young's Environmental. As a result of this withdrawal, pending results of our third audit, we were told we would not need to respond to the to the Complaint filed January 16, 2013.

I can personally assure you that as the Director of Health, Safety, and Compliance at Young's Environmental every attempt has been made to comply, and abide by the rules set forth by the Pennsylvania Public Utilities Commission. Again we ask that the order dated March 14, 2013 be rescinded, and determination of Young's Safety Fitness Review follow the scheduled April 9th audit.
