

(a) Complainant, Joseph Accardi, and Respondent, PPL Electric, agree that beginning with the bill due May 2013, Complainant will pay his budget bill plus \$450 per month towards arrearages, until all arrearages are paid in full. In addition, PPL Electric provided Complainant with an OnTrack application on April 4, 2013 and encouraged Complainant to complete the application.

(b) Complainant withdraws his Complaint.


