This letter is a follow-up to the Order of March 2, 2000 issuing Strategic Energy L.L.C. its License for Natural Gas Supplier regarding the bonding requirement at 66 Pa. C.S. §2208 (c)(1) for each of the natural gas distribution companies.

Status of bonding requirements with natural gas distribution companies is as follows:

Columbia Gas of Pennsylvania – Creditworthiness requirement met with financial information submitted. No bond required.

Per a conversation with Murray Hartzberg at Columbia today, he informed me that a Non-Choice marketer per their restructured tariff is not required to provide a bond. 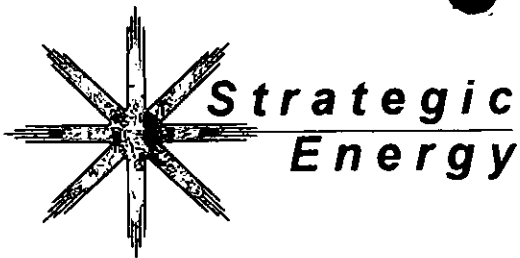

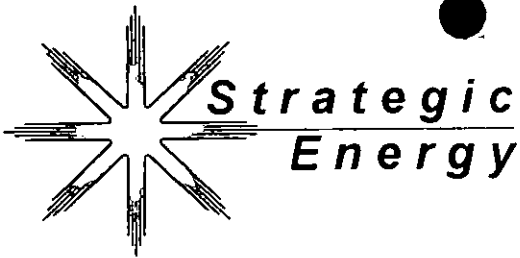

In the Commission's Order, entered March 2, 2000, at Docket No. A-125072, in Ordering Paragraph 3, the Commission directed the licensee to provide evidence of financial fitness with natural gas distribution companies (NGDCs) to the Commission pursuant to the bonding requirement at 66 Pa C.S. §2208(c).

Since the original Commission Order, Direct Energy Business, LLC (DEB) has revised the list of NGDC territories in which it intends to provide natural gas supply services. At this time, the list is as follows:

- PECO Energy Company
- UGI Penn Natural Gas, Inc.
- Columbia Gas of Pennsylvania, Inc.

DEB is currently in negotiations with the NGDCs listed in order to determine the amount/format of financial security required by DEB to serve customers. Upon finalization of the amount of financial security required, DEB will submit copies of the negotiated financial security instruments for each of the NGDCs in which it intends to serve customers (those listed above and/or any additional NGDCs) to the Commission as demonstration of compliance with the requirements of 66 Pa C.S. §2208(c).


