- (c) The Bureau of Fixed Utility Services, with the concurrence of the Law Bureau, recommends that each STAS filing be accepted and that each EDC be notified by Secretarial Letter that its recalculation has been accepted as filed.

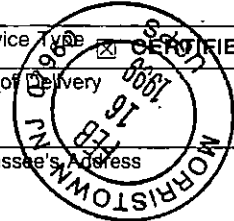

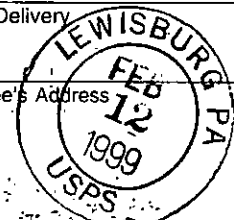

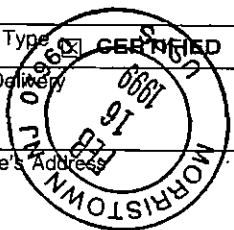
