PETITION TO INTERVENE OF THE PENNSYLVANIA INDEPENDENT OIL & GAS ASSOCIATION

Pursuant to 52 Pa. Code §§ 5.72-5.75, the Pennsylvania Independent Oil & Gas

Association (PIOGA) petitions to intervene in this matter involving, among other things: (i) the

transfer of EQT Corporation's natural gas distribution business – Equitable Gas Company, LLC

(Equitable) – to PNG Companies, LLC (PNG); (ii) the merger of Equitable with Peoples Natural

Gas Company, LLC (Peoples), a wholly-owned subsidiary of PNG, with Equitable to be

operated, initially, as a separate operating division of PNG; (iii) the transfer of approximately

200 miles of Peoples' regulated transmission pipelines and four Peoples' regulated storage pools

to affiliates of EQT Corporation; (v) the transfer of assets between Equitable and affiliates of

EQT Corporation; (v) the approval of long-term agreements for gas transmission, supply and

storage services related to the asset transfers and proposed changes in the companies' businesses;

and (vi) the approval of changes in Peoples' tariff. In support of its intervention, PIOGA avers as follows:

- 1. PIOGA is the comprehensive trade association representing oil and natural gas interests throughout Pennsylvania. PIOGA has over 900 members interested in natural gas development. PIOGA's members include natural gas producers that provide Pennsylvania-produced conventional and unconventional natural gas to Peoples, Peoples TWP, LLC and Equitable for system supply and to Commission-licensed natural gas suppliers and marketers (NGSs) for supply to retail customers on the three PUC-jurisdictional utilities' pipeline systems. PIOGA's members also include NGSs that provide natural gas supply services to retail customers on the three utilities' pipeline systems. PIOGA and producer members are long-term participants in Peoples' Pennsylvania natural gas production enhancement programs that have increased the availability and throughput of Pennsylvania-produced conventional natural gas on Peoples' system, and more recently have worked with Equitable to try to increase the availability and throughput of Pennsylvania-produced conventional natural gas on Equitable's system.

 On March 19, 2013, the three PUC-jurisdictional utilities filed the abovecaptioned Joint Application requesting the approvals necessary to effect the transactions described above and in the Joint Application.

Effective April 1, 2010, the Pennsylvania Oil and Gas Association (POGAM) merged into the Independent Oil and Gas Association of Pennsylvania (IOGA of PA) and the name of the organization changed to Pennsylvania Independent Oil & Gas Association (PIOGA).

- The proposed transactions clearly directly affect nearly all aspects of PIOGA 4. member producer and NGS operations on the systems of the companies involved in the transactions. PIOGA member producers and NGSs operate on Equitable's assets to be transferred to Peoples, and on the Peoples' system, and so are interested in the rates, terms and conditions applicable to the respective services to be provided as well as the storage services to be provided by Peoples post-transaction and other proposed Peoples' tariff changes. PIOGA member producers have interconnections on pipeline assets to be transferred from Peoples to EQT Corporation affiliates and will be affected by those transfers as well as by the transfers of assets between Equitable and EQT Corporation affiliates. The interests of PIOGA and its member producers and NGSs are affected by the proposed long-term agreements for gas transmission, supply and storage services agreements related to the transactions. The interests of PIOGA and its member producers and NGSs are also affected by the proposed changes in the focus of the business operations of the companies involved in these transactions, including the potentially different effects of the proposals on the availability of unconventional and conventional production for on-system and off-system end use and throughput.
- 5. The Commission's resolution of the issues raised by the transactions described herein and in the Joint Application will directly affect PIOGA and its producer and NGS members and be binding on PIOGA and its members operating on three PUC-jurisdictional utilities' systems and the other companies involved in the proposed transactions.
- 6. PIOGA and its member producers and NGSs will also be affected and bound by the Commission's resolution of issues raised by other parties that impact PIOGA member producer and NGS operations on these utilities' systems and the other companies involved in the proposed transactions.

7. PIOGA's interests and the interests of its producer and NGS members are not adequately represented by any other party in this proceeding, including other NGSs or PIOGA members that have intervened or may seek to intervene and participate individually, and that may raise issues specific to their relationships with the utilities and companies involved in the proposed transactions.

8. PIOGA's intervention is also in the public interest. PIOGA has participated in prior Peoples' proceedings before the Commission and the extensive experience of PIOGA and its members with operations on Peoples' system enables PIOGA to contribute to the full development of the record for the Commission's decision in this matter.

9. PIOGA is generally supportive of the aspects of the proposed transactions that will result in Peoples' takeover of Equitable's services and replacement of Equitable's rules and policies with Peoples', provided PIOGA producer and NGS members' operations and agreements are not adversely affected. PIOGA is cautiously supportive of the aspects of the proposed transactions that will enable the companies involved to provide greater opportunities for increased use and transportation of Pennsylvania-produced conventional and unconventional natural gas, again provided PIOGA producer and NGS members' operations and agreements are not adversely affected.

WHEREFORE, the Pennsylvania Independent Oil & Gas Association respectfully requests that its petition to intervene in this proceeding be granted.
