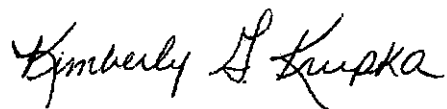
1. Complainant is James Stoudt.

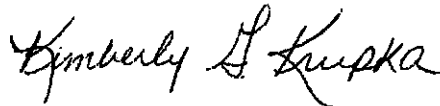
