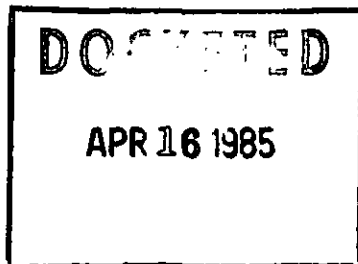

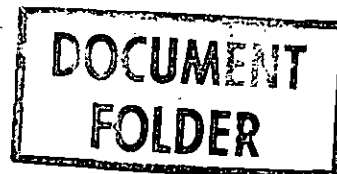

BY THE COMMISSION:

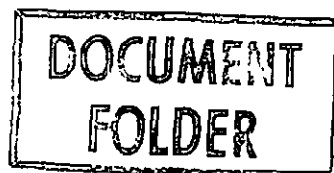
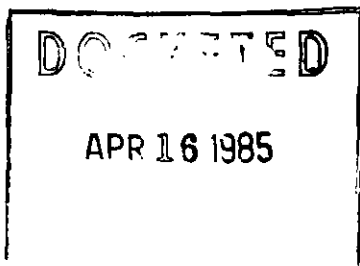
By order adopted March 15, 1985, at A-00105900, the Commission granted Phoenix Transport, Inc., a corporation of the Commonwealth of Pennsylvania, approval of the transfer to it all the rights granted to Julius G. Gardocky, Jr., at A-00095663.

Approval of the said transfer application inadvertently excluded the following right:

To transport, as a Class D carrier, property for National Steel Service Center, Inc., a division of National Steel Corp., from its plant in the city of New Castle, Lawrence County, to points in Pennsylvania, and vice versa; excluding the transportation of commodities in bulk in tank vehicles or in hopper-type vehicles.

Upon consideration of the matters herein we find that the order adopted March 15, 1985, in the transfer proceeding should have included the above operating authority; THEREFORE,

IT IS ORDERED: That the Commission's order adopted March 15, 1985, issued to Phoenix Transport, Inc., at A-00105900, be and is hereby corrected to include the omitted operating authority as described above.



IT IS FURTHER ORDERED: That the Commission's order adopted March 15, 1985, at A-00105900, of Phoenix Transport, Inc., shall remain the same in all other respects.
