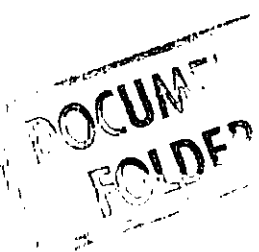
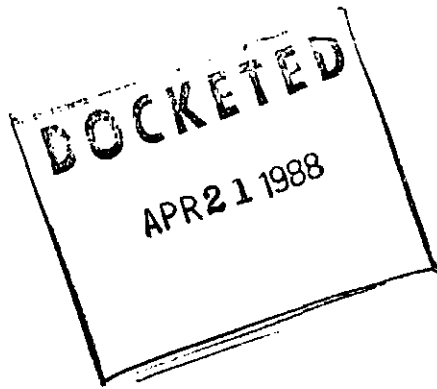
Gentlemen:
