

Should Commission Staff require any additional information, please do not hesitate to contact this office directly.

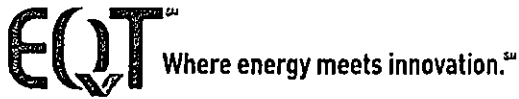
