CERTIFICATE OF SATISFACTION

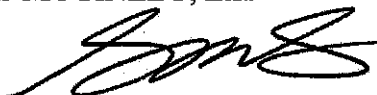
1. Complainant is Delia Velazquez.

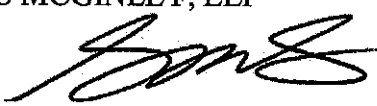
