
Dear Ms. Rinehart:



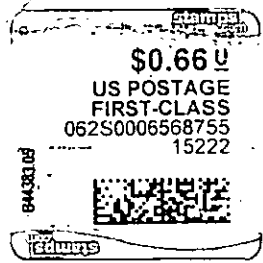
