Dear Secretary Chiavetta:

Core Communications, Inc. ("Core") hereby responds to the April 24, 2013 letter filed in the above-referenced matter by Verizon Pennsylvania Inc. and Verizon North LLC (collectively, "Verizon"), which encloses a copy of Judge Claude M. Hilton's Memorandum Opinion and Order in CoreTel Virginia, LLC v. Verizon Virginia LLC et al, Civil Action No. 1:12-cv-741 (E.D.Va.) ("Memorandum Opinion").

In response to Verizon's characterizations of the Memorandum Opinion and its relevance to the instant proceeding before the Pennsylvania Commission, Core notes that (1) the findings of fact and conclusions of law set forth in the Memorandum Opinion are erroneous and contrary to applicable law in many respects, and are subject to reconsideration and appeal, if need be; and (2) the Memorandum Opinion is premised on the terms of an interconnection agreement (ICA) which is not at issue in the case before the Pennsylvania Commission, and which does not bind the parties in the Pennsylvania case in any way.

In the event CoreTel Virginia LLC files any motion for reconsideration or appeals the final judgment in the Virginia case, Core will inform the Commission.


