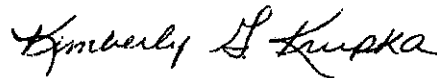

CERTIFICATE OF SATISFACTION

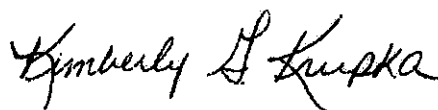
1. Complainant is David Miko.

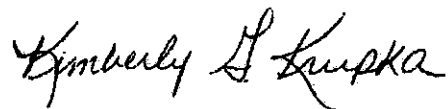
