CERTIFICATION

The following statements are provided in order to clarify Nazareth Ambulance Corps' response to answer #3 in the verified statements section of its submitted Application for Approval of Transfer and Exercise of Common Carrier or Contract Rights.

Nazareth Ambulance Corps is a non-profit corporation that provides EMS ambulance service to the Nazareth region. In addition, Nazareth Ambulance Corps provides ALS and BLS emergency and non-emergency services to Gracedale, a nursing home owned by Northampton County. As part of the non-emergency services provided to Gracedale, Nazareth Ambulance performs wheel chair van service (para-transit) to non-ambulatory residents in medically equipped vans staffed with a driver and an EMT. The residents are transported from and returned to Gracedale after visits to local hospitals and physicians' offices in order to receive various health services.

I, Daniel Chiavaroli, Executive Director of the Nazareth Ambulance Corps, hereby state that the facts above set forth are true and correct to the best of my knowledge, information and belief, and that I expect to be able to prove the same at a hearing held in this matter.
