

AND NOW comes Respondent PPL Electric Utilities Corporation ("Respondent"), and files the within Reply to Complainant's Exceptions, alleging in support thereof as follows:

1. Given Complainant's Exceptions' non-compliance with 52 Pa.Code §5.533 (b), and (meaning no disrespect) the general incomprehensibility of same, it is not possible for Respondent to directly respond to Complainant's Exceptions in the usual and customary manner. However, Respondent will endeavor to do its best to respond to each separate exception raised by Complainant.

2. In general, Respondent replies to Complainant's Exceptions by noting that all of the findings of fact and conclusions of law set forth in the Administrative Law Judge's Initial Decision in this case are well supported by the evidence presented at Hearing, and the laws of this Commonwealth.

3. Respondent is without knowledge, information, or belief necessary to respond to Complainant's claims regarding what "STEP" required of him, or whether he could objectively comply with any such requirements.

4. Respondent denies that the "statute of limitations" has any applicability to any issue of relevance to Complainant's Complaint.

5. As found by the Administrative Law Judge in his Initial Decision, Respondent, at all times, fully complied with each and every provision of Act 54.
