

On July 10, 2003, PPL Electric Utilities Corp. ("PPL") filed a Letter of Notification with respect to the proposed West Hempfield – McGovernville #1 and #2 138/69 kV transmission tie line to be constructed in East Hempfield Township, Lancaster County, Pennsylvania. This case was docketed at No. A-110500F0333 and assigned to FUS on July 11, 2003 by the Secretary's Bureau.

On March 30, 2004, PPL filed an Application for Approval of its Proposed Exercise of the Power of Eminent Domain to Acquire Right-of-Way for the construction, operation and maintenance of the proposed West Hempfield – McGovernville #1 and #2 138/69 kV transmission tie line. This Application was docketed at A-110500F0342, A-110500F0343 and A-110500F0344 and assigned to the Office of ALJ.

In the Applications, PPL requests that the Applications be consolidated with the pending Letter of Notification at Docket No. A-110500F0333, pursuant to Pa. Code, §57.75(i)(1).

After a discussion between FUS staff and Eric Rohrbaugh of the Office of ALJ, it was determined that the Letter of Notification should be consolidated with the Applications. Thus, we are requesting that the Secretary's Bureau reassign the Application at A-110500F0333 to the Office of ALJ, such that it can be consolidated with the Applications.




