The verified statement should be in paragraph form. Each heading contained in the attached minimum outline should be a separate section or paragraph.

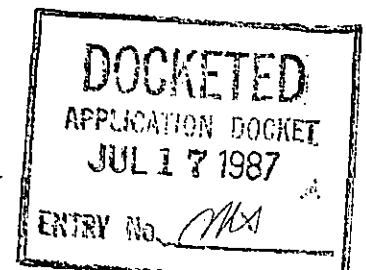
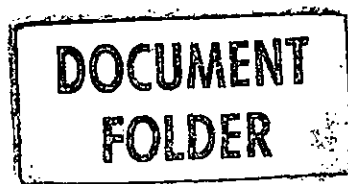
You are being granted an initial thirty (30) days in which to file the verified statements. The statements are due on or before AUGUST 17, 1987.

This letter is to serve as an addendum to our letter of July 14, 1987 requesting that you file for a P.U.C. Eemergency Temporary Authority.

We would like to reiterate that we are still in need of a service oriented carrier for our heavy volume of PA. destined freight. Tex-Ark Joist has called other carriers such as T.J. Heilig, Inc., Lebanon, PA. and also Daily Express Inc. for a five (5) load move for same day delivery to High Steel, Lancaster, PA. Neither carrier could accomodate our service requirements.

High Steel then suggested contacting Pioneer Transport, Inc. As it has the authority to handle movements into and out of its facilities. Pioneer did have the equipment necessary for pick up and delivery on July 7, 1987. Your service is what prompted the letter of July 14, 1987 from our Lebanon plant manager Dave O'Brien.

We have not supported any other applications for any authorities, and are again requesting you file immediately, with our support, so that Pioneer Transport can continue to service our Lebanon, PA facility.

Our operation in Lebanon is presently a non-union facility and we are not intending any immediate negotiations.

Accordingly, it is my understanding that the Verified Statements will now be due on or before September 17, 1987.

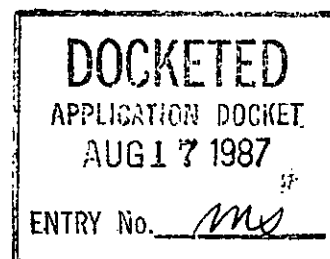
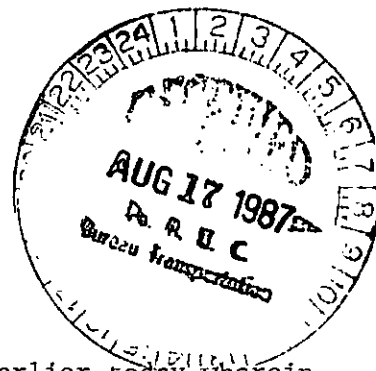
