**STATUS REPORT OF THE DEPARTMENT OF TRANSPORTATION**


The Pennsylvania Department of Transportation (“Department”) hereby files the following Status Report, pursuant to the requirements of Ordering Paragraph 21 in the Commission’s Opinion and Order entered October 31, 2007, in the above-referenced matter. This status report pertains to the work ordered to be performed by the Department pursuant to the Commission’s Opinion and Order entered on October 9, 1997, as subsequently modified.

1. The Department’s Marticville Road (S.R. 0324) project is under construction. The construction is expected to be completed December 31, 2013.

2. Pumping Station Road is now pending in the Office of Administrative Law Judge. The parties are discussing a possible amicable resolution of the matter and have requested a 90 continuance of the July 2013 hearing.




