Please be advised that PPL Electric Utilities Corporation (“PPL Electric”) will not be filing Reply Comments in response to the Comments filed by the Office of Consumer Advocate (“OCA”) in which OCA stated that it has no objection to the approval of the Amendment to Revised Default Service Program and Procurement Plan (“Amendment”) filed on April 26, 2013, in this proceeding. In a letter filed May 6, 2013, the PP&L Industrial Customer Alliance (“PPLICA”) stated that it would not be filing comments on the Amendment; however, PPLICA explained that it filed comments on April 4, 2013, in this proceeding addressing certain cost recovery issues. PPL Electric, on April 10, 2013, filed Reply Comments fully responding to PPLICA’s comments on the recovery of costs related to the retail market enhancement programs. 
