- (b) On February 4, 2006, Pennsylvania-American Water Company (PAWC) and Redstone Water Company (Redstone) filed Joint Applications for the transfer of assets of Redstone's Crescent Heights (Washington County) and Allison I & II Water Systems (Fayette County) to PAWC.
Concurrent with these Applications, PAWC filed Applications to acquire the assets of the Allison I & II Water System owned by Redstone Township and Luzerne Township, Fayette County, respectively (and collectively known as the Townships). PAWC, additionally, filed executed Municipality Agreements with the Townships (Redstone – February 8, 2006 and Luzerne – February 14, 2006).
On-going proceedings involved with these Applications are the continuing status reporting to the Commonwealth Court and 17 active Formal Complaints against Redstone. With the approval of the above, all active proceedings can be closed.

ORDER

BY THE COMMISSION:

By Joint Application filed on February 4, 2006, Pennsylvania-American Water Company (PAWC) and Redstone Water Company (Redstone) seek certificates of public convenience pursuant to Sections 1102(a)(1)(i) and (3) of the Public Utility Code, 66 Pa. C.S. §1102(a)(1)(i) and (3), evidencing Commission approval of: (1) the transfer, by sale, of the waterworks property and rights of Redstone in the systems (or divisions) commonly known as the "Crescent Heights Water System" located in West Pike Run Township, Washington County and the "Allison I & II Water System" located in Redstone Township and Luzerne Township, respectively, Fayette County; (2) the right of PAWC to begin to offer water service to the public in the Crescent Heights and Allison service areas, and, (3) pursuant to Sections 1102(a)(2) of the Public Utility Code, 66 C.S. §1102(a)(2) the right of the abandonment or discontinuance by Redstone of water service in said Crescent Heights and Allison service areas of Washington and Fayette Counties.

Concurrent with the above Applications, PAWC filed, pursuant to Sections 1102(a)(1)(i) and (3) of the Public Utility Code, 66 Pa. C.S. §1102(a)(1)(i) and (3), for the approval of (1) the transfer, by sale, of the water works and property rights of Redstone Township to PAWC; and (2) the right of PAWC to begin to offer service to the public in

the “Allison Hill Water System” consisting of additional portions of Fayette County. This included an additional filing relating to an identical transfer of waterworks property and rights in Luzerne Township, Fayette County, pursuant to Sections 1102(a)(1)(i) and (3) of the Public Utility Code, 66 Pa. C.S. §1102(a)(1)(i) and (3).

Additionally, on February 8, 2006, and February 14, 2006, PAWC filed executed Municipality Agreements with Redstone Township and Luzerne Township, respectively, pursuant to Section 507 of the Public Utility Code, 66 Pa. C.S. §507. These filings are in conjunction with the above asset purchase agreements with the Townships.

PAWC submitted proofs of service and publication. The Commission received no protests or motions and no hearing was held.

PAWC is a jurisdictional public utility water company, duly organized and existing under the laws of the Commonwealth of Pennsylvania, and is a wholly owned subsidiary of the American Water Works Company, Inc. PAWC presently provides water service to more than 616,000 residential, commercial, industrial and other customers in certificated service territories encompassing portions of 35 counties across the Commonwealth. PAWC also furnishes wastewater service to over 13,000 customers.

Redstone is a small water purveyor in southwest Pennsylvania with three stand-alone water systems. Redstone has been a troubled jurisdictional company for the Commission for the past decade. Redstone was directed by Commission Order entered June 28, 2005 to interconnect its Crescent Heights Water System with Tri-County Water Authority or sell the system at a reasonable price to a viable entity within 180 days of the Order. On July 27, 2005, Redstone filed a Petition for Review in Commonwealth Court, docketed at 1534 C.D. 2005, from the Commission’s Order. On December 23, 2005, Redstone and PAWC executed an Asset Purchase Agreement. The matter at hand is the

asset transfer of the Crescent Heights Water System and the Allison I & II Water System that involves 260 and 230 customers, respectively. All residential customers own and maintain their own individual wastewater treatment systems.

PAWC avers it will interconnect with the Crescent Heights Water System from its 16-inch diameter cement lined ductile iron main that is installed along US Route 40 to the south of Crescent Heights. PAWC further states that it will attempt to accomplish this interconnect prior to closing to abate a contamination concern (hardness) in a show of good faith.

The agreed purchase price for all waterworks of the Crescent Heights Water System is \$499,000. This agreement was an arm's length accord.

The Allison I & II Water System is currently interconnected to the Southwestern Pennsylvania Water Authority. PAWC does have an 8-inch cement lined, ductile iron main nearby and expects to interconnect in the near future. The Allison I & II Water System had 6-inch PVC lines installed by the respective townships for the purpose of fire protection. These are the assets that PAWC is purchasing. PAWC will pay Redstone Township \$17,500 and Luzerne Township \$12,500 for their respective pipelines and appurtenances.

PAWC avers it will conduct an original cost study of the Crescent Heights and Allison I & II Systems.

PAWC proposes to apply Redstone's tariff rates that are currently in effect, except for fire hydrants. Thus, a typical residential customer using 60,000 gallons of water annually pays about \$513. This rate will remain in effect until further Commission

notice and consideration. Current PAWC rules and regulations will take effect immediately following closing.

In the asset purchase Applications and the Municipality Agreements with both Townships, PAWC will charge an initial annual rate of \$25 per hydrant billed on a monthly basis. This rate will increase by \$20 per hydrant per year over the subsequent five years. Any future increases will be subject to Commission approval.

Lastly are the issues concerning the aforementioned proceedings; i.e., the Commonwealth Court Appeal at B-00053985 that is related to the Commission's June 28, 2005 Order at C-00992270 *et al.* Commission approval of the transfer of the Crescent Heights and Allison I & II Water Systems to PAWC will result in compliance with the Commission's June 28, 2005 Order. Redstone has stated in an Application for General Continuance filed in Commonwealth Court on November 9, 2005 that the sale of its water system will obviate the need for Commonwealth Court review of the Commission's June 28, 2005 Order and result in a discontinuance of this matter. (Application for General Continuance, Para. 7.)

Upon consideration of these factors, we conclude that the record provides substantial evidence of affirmative public benefit sufficient to warrant approval of the proposed transaction under *City of York v. Pennsylvania Public Utility Commission*, 449 Pa. 136, 295 A.2d 825 (1972); **THEREFORE,**

IT IS ORDERED:

1. That the Joint Application of PAWC and Redstone at Docket Nos. A-212285F0129 and A-212490F2001 are hereby approved.

2. That certificates of public convenience shall be issued pursuant to Section 1102(a)(1)(i) and (3) of the Public Utility Code, 66 Pa. C.S. §1102(a)(1)(i) and (3), authorizing PAWC to begin to offer, render, furnish, or supply water service to the public in portions of West Pike Run Township, Washington County and Redstone Township and Luzerne Township, Fayette County, upon verification to the Secretary of the Commission of closing.

3. That the Applications of PAWC at Docket Nos. A-212285F0130 and A-212285F0131 are hereby approved.

4. That certificates of public convenience shall be issued pursuant to Section 1102(a)(1)(i) and (3) of the Public Utility Code, 66 Pa. C.S. §1102(a)(1)(i) and (3), authorizing PAWC to begin to offer, render, furnish, or supply water service to the public in portions of West Pike Run Township, Washington County and Redstone Township and Luzerne Township, Fayette County, upon verification to the Secretary of the Commission of closing.

5. That the Municipal Agreements at Docket Nos. U-00065270 and U-00065271 between PAWC and Luzerne Township and Redstone Township, respectively, are hereby approved and the Secretary issue appropriate certificates of filing.

6. That PAWC will immediately interconnect its 16 inch cement lined ductile iron main along US Route 40 to Crescent Heights Water System upon the entry of this Commission Order and prior to closing.

7. That nothing herein shall be construed to exempt PAWC from obtaining all necessary permits, licenses and approvals from other state, federal and local government agencies having jurisdiction.

8. That PAWC will file with the Commission's Secretary and Bureau of Fixed Utility Services an original cost study of the waterworks acquired under the terms of the asset purchase agreements when it becomes available.

9. That PAWC shall file a compliance tariff containing the existing rates of Redstone and the current rules and regulations of PAWC no later than 10 days after closing.

10. That a copy of this Order be served upon the Office of Trial Staff, the Office of Consumer Advocate, the Office of Small Business Advocate, the Department of Environmental Protection's (DEP) Bureau of Regulatory Counsel and DEP's Southwest Regional Office and the Department of Revenue – Bureau of Corporation Taxes and all parties of record at C-00992270.

11. That upon compliance with Ordering Paragraphs 6 and 8, the dockets at A-212285F0129, A-212490F2001, A-212285F0130, A-212285F0131, U-00065270, U-00065271 and C-00992270 *et al* be marked closed by the Commission Secretary's Bureau.
