
Dear Secretary Chiavetta:

Enclosed herewith are three copies of 13th Revised Page 72 cancelling 12th Revised Page 72 to Tariff Freight Pa P.U.C. No. 50, issued by Tristate Household Goods Tariff Conference, Inc., Agent, for its members under power of attorney, and sent to you in compliance with the requirements of the Pennsylvania Public Utility Law.

Fischer-Hughes of Allentown, Inc. @ A-001105456 has applied its local hourly rates from Transportation Rate Table GG in Tariff Freight Pa. P.U.C. No. 50 (50-T) issued by Tristate Household Goods Tariff Conference, Inc., Agent.

For calendar year 2012 your applicant generated total revenues of \$9,874,125 and expenses of \$9,643,438 or an operating ratio of 97.6%. Of that total revenue figure only \$4,247 applied to the transportation of household goods in use. Attached is a copy of applicants assessment report for calendar 2012. Unlike four other Tristate members who are also a part of this group applying the county rate table GG and provide considerably more local moving revenue and who have enclosed its Wage Cost Study Form it has not been provided for this applicant. Applicant desires to continue its place with other movers in spite of its Pa. revenues. The proposed loose-leaf revision to Tariff Freight Pa. P.U.C. No. 50 has been filed on sixty (60) day advance notice with a tentative effective date of July 15, 2013 unless further suspended.
