Dear Secretary Chiavetta:

By this letter, Duquesne Light Company (“Duquesne Light” or “Company”) hereby notifies the Commission and interested parties that a 180 day deadline has been established for the submission of incentive applications following the in-service date of the measure for the Energy Efficiency and Conservation Phase II Plan (“EE&C Phase II Plan”).

On November 15, 2012, Duquesne Light filed its EE&C Phase II Plan with the Pennsylvania Public Utility Commission (“Commission”). On March 14, 2013, the Commission issued an Opinion and Order approving the Company’s EE&C Phase II Plan and directing the Company to establish a deadline for the submission of incentive application for conservation service measures following the in-service date of the measure. Pursuant to this Order, the Company established a 180 day deadline. The established timeframe has been communicated to the Company’s CSPs, as well as interested stakeholders at the Company’s May 9, 2013 stakeholder meeting. The timeframe will also be provided on the Phase II application.


