
I am very sorry about misunderstanding that is going on. I decide to stay no longer in business about February 15-17/2013. At the same time, I sent a letter to US DOT FMCSA about revocation of authority and notified insurance agency about that. My last day of insurance coverage was 3/8/2013 and agent told me they will notify PUC office about cancellation of insurance, because they responsible for renew or cancel insurance policy. I got decision from US Dot about revocation of authority effective 02/27/2013 (I provide a copy of that letter). When I got a notice from PUC office about suspension of PUC Truck Operating Authority, I understood, your office does not have any notification about revocation of my authority. I contacted by phone 717-787-1227 and one of your representatives told me I have to send a letter to ask to cancel my PUC A-8910134 because I am no longer in business. I sent that

letter to your office on 04/23/2013. A few days later I got other letter from you that advised me about filed complaint against me. I contacted your office by phone on 05/07/2013 to ask what I have to do to solve any problems. Representative told me that I have to provide a detailed letter about that, which I try to do by this letter.
