
Dear Secretary McNulty:

Dear Secretary McNulty:

In compliance with the above-referenced Order of the Pennsylvania Public Utility Commission, Commonwealth Telephone Company ("CTCo") respectfully submits the following data regarding its 3-year intraLATA equal access cost recovery.

As of March 2003, CTCo has billed \$370,410 of the \$ 668,371 total costs of intraLATA equal access. Based on this recovery rate, CTCo anticipates the \$0.000333 per-minute equal access cost recovery charge would need to remain in effect through September 2004.

CTCo will provide updated information to the Commission regarding intraLATA equal access cost recovery in its next report scheduled for March 2004.


