In Comments filed on April 25, 2013 in this proceeding, the Office of Consumer Advocate (OCA) identified an issue regarding Philadelphia Gas Works' (PGW) proposal not to apply the DSIC to its Rate IT customers. OCA Comments at 10.

In its May 9, 2013 Order, the Public Utility Commission directed the parties to advise the Office of Administrative Law Judge within 20 days if there are any remaining contested issues.

After discussion, the OCA and PGW have agreed that there is no need to pursue the issue at this time. The OCA is authorized by PGW to represent the OCA and PGW's agreement that the applicability of the DSIC to Rate IT can be addressed in PGW's next base rate case.


