MOTION FOR PROTECTIVE ORDER

Now Comes, Telrite Corporation d/b/a Life Wireless (“Telrite” or the “Company”) by this Motion seeking a protective order from the Pennsylvania Public Utility Commission for withholding from public disclosure certain information filed with the Commission in this proceeding that the Company asserts is a “confidential proprietary record” under the Pennsylvania Right-to-Know Law (Act 3 of 2008, 65 Pa. C.S. §§ 67.101 *et seq.*) This Motion is submitted pursuant to 52 Pa. Code § 5.423(b).

Specifically, the Company has filed with this Motion, as Exhibit A:

- Profit & Loss Statement, and Balance Sheet, for the period January through December 2012.

The Company is privately held and does not disclose to the public its financial information. The Company operates in a highly competitive business environment and public disclosure of the financial information contained in Exhibit A would cause substantial harm to the maintenance of its competitive position. The Affidavit of Brian Lisle, the President of the Company, is annexed hereto attesting to the foregoing facts.

The Right-to-Know Law defines “confidential proprietary information,” at Section 101, as

“[C]ommercial or financial information received by an agency:
(1) which is privileged or confidential; and
(2) the disclosure of which would cause substantial harm to the competitive position of the person that submitted the information.”

The Right-to-Know Law exempts, at Section 708(b)(12), a “trade secret” or “confidential proprietary information” from an agency’s obligation to provide to a “requester” access to a “record” on file with the agency.¹ The Company requests that the Commission extend said exemption to the Company’s financial information contained in Exhibit A. Accordingly, the Company requests that the Commission issue a Protective Order stating specifically that the information in Exhibit A of this Motion be disclosed only the Staff members directly involved in this proceeding, and that any pleading or other filings that incorporate, reference or attach this financial information or any portion thereof be submitted under seal.

Public copy of this Motion with Exhibit A redacted has been filed with the Secretary. A copy of this Motion without redaction also has been filed with the Secretary under seal, with the information contained in Exhibit A marked as “CONFIDENTIAL.”


