On February 21<sup>st</sup>, 2013, our firm filed the requisite application on behalf of North American Power and Gas ("NAPG" or "Applicant") for licensure as a Natural Gas Supplier ("NGS") by the Pennsylvania Public Utilities Commission ("PAPUC" or "Commission") in accordance with Title 66, Subpart D, Ch. 22, § 2208 *et seq.* 

On May 16, 2013, NAPG received notification that the PAPUC was extending the forty-five (45) day period for review as required under 52 Pa. Code 62.109(b). Pursuant to 52 Pa. Code § 5.44, the Applicant has the option to petition the Commission within twenty (20) days of the date of the aforementioned letter if they are dissatisfied with the resolution of the above captioned matter.

In addition, the PAPUC requested that the Applicant provide the waiver letter from Equitable Gas Company stating that NAPG meets their credit requirements as outlined in their Tariff, based upon the satisfactory creditworthiness disclosed in NAPG's consolidated financial statements. That letter was included in the original filing as *Exhibit 17(b)*, and is attached hereto for your convenience.

Since the original filing dated 21 February, there has been a change in the corporate structure of NAPG. Mr. Michael D'Angelo, Esq. was designated as the regulatory contact and General Counsel for North American Power and Gas. The Applicant no longer employs Mr. D'Angelo. NAPG herein notifies the Commission that the following employees are designated as the Regulatory Contact and attorney.


