Duquesne Light respectfully requests that the Pennsylvania Public Utility Commission consider this Letter of Notification on an expedited basis. As explained in the Letter of Notification, Duquesne Light must disconnect its facilities from the permanently retired Elrama Power Plant by February 2014. To achieve this milestone, construction of the proposed Project is scheduled to begin in September 2013, or as soon as practical upon receipt of the Commission's approval. The final in-service date of for the entire Project is June 1, 2015.
