

Code §5.103, respectfully petitions this Honorable Commission to grant Respondent an extension of time to file its Answer to Complainant's Petition for Reconsideration, for the following reasons:


1. Complainant filed a Petition for Reconsideration with the Commission on June 13, 2013.
2. Commission regulations require a copy of the petition to be served upon each party to the proceeding. 52 Pa. Code §5.572(b).
3. Complainant did not serve Respondent with a copy of the Petition.
4. Respondent's counsel discovered that Complainant had filed the Petition after the end of the business day on June 12, 2013.
5. Commission regulations require Answers to Petitions to be filed and served within 10 days after service of a petition.

6. 10 days after June 12, 2013, the date that Respondent learned of Complainant's Petition, is June 22, 2013.


