PPL Electric hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL Electric:
  - (a) Complainant, Catherine Roberts, and Respondent, PPL Electric, agree that Complainant will pay \$317 by July 1, 2013. Thereafter beginning with the bill due August 2013, Complainant will pay her current bill plus \$56. At the request of the Complainant, PPL Electric is removing Complainant from budget billing as of August 2013. Complainant may call PPL Electric in the fall to request budget reinstatement.
  - (b) Complainant agrees to withdraw her Complaint.

5. Respondent, PPL Electric hereby notifies Complainant of the filing of this Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of the Certificate of Satisfaction, Complainant must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.
