On May 23, 1997, a Petition to Intervene was filed by the Pennsylvania Petroleum Association. No objection was raised to this request.

Therefore, the Petition is granted and, pursuant to the request contained in that Petition, the Pennsylvania Petroleum Association is to be considered an active party in this proceeding and should be added to the active party service list.<sup>1</sup>

They are expected to attend hearings, present witnesses and conduct discovery and cross-examination. Inactive parties will receive only hearing notices, the recommended decision, and the Commission order. They may participate and give testimony at public input hearings which will be held at various locations in PECO's service territory.
