PUBLIC STATEMENT OF THE  
OFFICE OF CONSUMER ADVOCATE  
PURSUANT TO 71 P.S. SECTION 309-4(e)

Act 161 of the Pennsylvania General Assembly, 71 P.S. § 309-2, as enacted July 9, 1976, authorizes the Consumer Advocate to represent the interests of consumers before the Pennsylvania Public Utility Commission (PUC or Commission). In accordance with Act 161, and for the following reasons, the Consumer Advocate determined to file an Intervention and participate in proceedings before the Commission involving PPL Electric Utilities Corporation.

On June 6, 2013, the Office of Small Business Advocate (OSBA) filed a Complaint against PPL's May 17, 2013 Generation Supply Charge Reconciliation Report. The OSBA has raised concerns regarding the methodology used to establish small commercial and industrial default service rates. The OSBA's Complaint directly addresses the method and results of PPL's pricing methodology for residential customers.

The Office of Consumer Advocate (OCA) has intervened in this proceeding to help ensure that PPL's default service is priced appropriately and that any modifications to that pricing structure that may result from this proceeding do not negatively impact customers.


