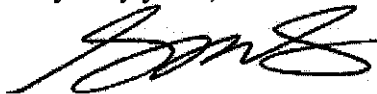

CERTIFICATE OF SATISFACTION

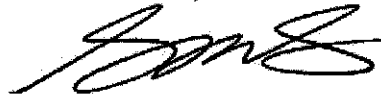
1. Complainant is Jennifer and Joshua Drouin.

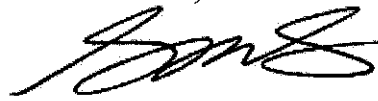
