
**BY THE COMMISSION:**

Pursuant to the provisions of 52 Pa. Code §§ 3.1 - 3.5, the issuance of an emergency order is subject to ratification by the full Commission at its next scheduled public meeting. Upon consideration of the matter involved, we find that ratification of the September 17, 1998 emergency order granting the Mid-Atlantic Power Supply Association's request, as modified by the emergency order, for clarification of August 13, 1998 Secretarial Letter Order, and directing PECO Energy Company to assign a portion of the load reserved for economic development purposes to the "Large GS" class in an amount to eliminate the need for pro-rating the load shares among these customers, is consistent with the public interest; THEREFORE,

IT IS ORDERED:

1. That the September 17, 1998 emergency order issued by Chairman John M. Quain is hereby ratified.
2. That a copy of this order shall be served on the Office of Consumer Advocate, the Office of Trial Staff, the Office of Small Business Advocate, the Secretary of the Department of Community and Economic Development, all jurisdictional electric distribution companies and all licensed electric generation suppliers, and all parties of record in the PECO Energy Company Restructuring proceeding at R-00973953.

**EMERGENCY ORDER**

On August 25, 1998, the Mid-Atlantic Power Supply Association (MAPSA) filed a request for clarification of the Commission's August 13, 1998 Secretarial Letter (Secretarial Letter) at the above-captioned docket. In its filing, MAPSA states that the Secretarial Letter modified certain provisions of the Commission's May 21, 1998 Order that established enrollment and selection procedures for direct access. Features of this Final Order had been incorporated into the Tariff filed by PECO Energy Company (PECO) that had resulted from the Commission's approval of the Joint Petition for Full Settlement. Application of PECO Energy for Approval of its Restructuring Plan Under Section 2806 of the Public Utility Code and Joint Petition for Partial Settlement, R-00973953, Order entered May 18, 1998. Specifically, the Secretarial Letter extended the deadline for initial customer enrollment for direct access from August 14, 1998 to August 27, 1998.

MAPSA states that the customer enrollment extension to August 27, 1998 may result in customer classes that were not oversubscribed on the original date becoming oversubscribed as a result of the lengthened enrollment period. MAPSA explains that the only customer group that it is aware of for which over-subscription is a problem is PECO's "Large GS" Group. According to PECO's

enrollment update as of August 19, 1998, of the 376,081 KW of load for that class, 373,598 KW was subscribed. Thus, this group was under-subscribed on August 14, 1998, but is likely to be over subscribed by August 28, 1998.

MAPSA argues that a small over-subscription of the large "GS" group should not result in the cumbersome and confusing pro-rationing of a few percent of the load for more than 3,000 customers. MAPSA states that there is ample unsubscribed load available in PECO's GS class as a whole. According to PECO's enrollment update as of August 19, 1998, only 39% of the available "Small GS" load of 681,477 KW has enrolled, meaning that this portion of the rate class is under-subscribed by 400,000 KW. MAPSA suggests that a portion of the "Small GS" load could be shifted to the "Large GS" group to avoid the severe problems of prorating more than 3,000 customers in terms of forecasting, scheduling, reconciling, metering, billing, etc.


Although MAPSA's suggestion has some appeal, it would be unfair to "Small GS" customers to further limit their ability to participate in direct access. Instead, a more equitable solution is to assign to the "Large GS" customer class 32 MW of the 119 MW that was reserved for economic development purposes for PECO in our order at Procedure for Approval of Petitions to Access Portion of Phase In Load Reserved for Economic Development Purposes, Order entered August 17, 1998 at Dkt. No. M-00981157. Assigning 32 MW of this reserved load to the "Large GS" customer group will still leave 87 MW of load available for economic development purposes. As there have been no petitions to access this load filed to date with the Commission, transferring a portion of this available load to the "Large GS" customer group is preferable to transferring load within PECO's GS customer group.

In light of the fact that the above solution would increase the participation level in direct access of "large GS" customers without penalizing other customers taking service at the same tariff rate, granting MAPSA's request for clarification and releasing a portion of PECO's economic development load for use by "Large GS" customers will not harm any aspect of the public interest. Accordingly, subject to ratification by the Commission at its next scheduled public meeting subject to the provisions of 52 Pa. Code §§3.1-3.5, I will approve MAPSA's request for clarification of the August 13, 1998 Secretarial Letter and will direct PECO Energy Company to assign a portion of the load reserved for economic development purposes to the "Large GS" class in an amount that will eliminate the need for pro-rating the load shares among the customers; THEREFORE, IT IS ORDERED:

1. That the Request of the Mid-Atlantic Power Supply Association for Clarification of August 13, 1998 Secretarial Letter Order is hereby approved as modified by this emergency order.
2. That PECO Energy Company is directed to assign a portion of the load reserved for economic development purposes to the "Large GS" class in an amount that will eliminate the need for pro-rating the load shares among these customers.
3. That pursuant to 52 Pa. Code § 3.3, a copy of this order be served upon all Commissioners, the Executive Director and the Secretary; and
4. That this order be served on the Office of Trial Staff, the Office of Consumer Advocate, the Office of Small Business Advocate, the Secretary of the Department of Community and Economic Development, all jurisdictional electric distribution

companies, all licensed electric generation suppliers and all parties of record in the PECO Energy Company Restructuring proceeding at R-00973953.
