

PETITION FOR RECONSIDERATION....F-2012-2284038..


1. Your own statement nullifies the 2nd case of foreign wiring for the first floor tenant. In your OPINION AND ORDER ,page 7 the new paragraph states "The ALJ also noted that a second instance of foreign wiring was discovered on February 8,2012, at the Complainant's rental property be PECO, whereby the third floor refrigerator outlet was thought to be connected to the first floor electric service. FOF Nos. 12,13,41. Further investigation by the Company found that the third floor refrigerator was actually wired to the house meter,which was determined to constitute foreign load." The house meter is in my name, not the first floor tenants.So obviously this second instance is not foreign wiring to the first floor tenant and her bill should not have been transferred to me.

2. Again I bring up trespassing. Peco is not allowed to enter private property without the permission of the owner. For example,let's say Peco went to someones house because they wanted to test the meter inside the house. They walk up to the door which is unlocked but nobody answers the door. Are you telling me they can enter the premise to access the meter...I THINK NOT! It is no different in my case. The tenant did not have permission to access the basement,the basement is not part of her premises, therefore Peco needs permission of the owner to enter. They are not allowed to enter private property without permission. While Peco has the right to access their equipment, it doesn't mean they can enter private property without permission. Because by that logic they would be allowed to access the house in my example, and clearly they are not allowed to enter that house.

3. I am enclosing the letter Peco sent m e after the first case of foreign wiring. They never revised or sent a follow up letter,even though i called numerous times an explained to them that according to this letter I am only responsible for the portion of the tenants bill that is attributable to the found foreign wiring.So...according to this letter...and they even highlighted the section of the paragraph...i was not responsible for her entire bill.

4. Peco made so many negligent mistakes concerning this whole matter and i have documented the above three..there are more... that this bill should be taken out of my name.



Dear Sir:

On 4-13-11 a PECO field technician visited the above referenced property in response to a high bill complaint. The technician found that the entrance, hallway, and stairway lights are connected to the 1<sup>st</sup> PI meter. This is known as foreign wiring. Please have your electrician check for any additional foreign wiring that may not have been detected at the time of the field visit.

When PECO identifies foreign wiring, Pennsylvania State Law requires the electric service to be transferred into the name of the landlord, until the wiring is properly corrected. (Per Section 1529.1(b) of the Pennsylvania Public Utility Code, 66 Pa. C.S. 1529.1)

Please be advised that the electric service for the accounts in question will be transferred into your name effective immediately. If any of the current tenants' balance due is attributable to the found foreign wiring, the portion of that balance attributable to the foreign wiring will be transferred into your name as well.

The service can only go back into your tenants name if you have your electrician correct the wiring for each apartment.
