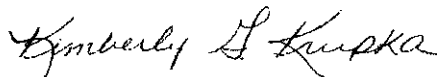

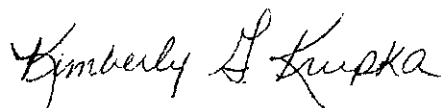
1. Complainant is Sleep Disorder Centers of PA.
