

(a) Complainant, Justin Roberson, and Respondent, PPL Electric, agree that Complainant has been enrolled in the OnTrack program. Complainant and Respondent further agree that Respondent will credit Complainant’s account in the amount of \$30.00, which represents Complainant’s reconnection fee. Last, Complainant and Respondent agree that Complainant’s account currently has an On-Track credit in the

amount of \$268.57, which will be applied to his monthly bills, beginning with Complainant's bill that is due in August of 2013.

(b) Complainant agrees to withdraw his Complaint.
