Dear Judge Kashi:

On December 22, 1997, PP&L, Inc. filed a Petition to further amend the procedural schedule in the above-captioned proceeding producing a delay in the filing date for the main brief from January 9, 1998, to February 10, 1998, and a Commission Order from April 30, 1998, to May 28, 1998. As noted in paragraph 6 of the PP&L Petition, the PP&L Industrial Customer Alliance opposes this latest proposed extension. Settlement discussions have not advanced substantially since September 10, and this extension will place the Pennsylvania Public Utility Commission in the unenviable position of simultaneously deciding the PP&L Restructuring proceeding with the West Penn Power Company and Duquesne Light Company Restructuring proceedings, both of which also have main briefing dates of February 10, 1998.

PP&L Industrial Customer Alliance recommends a denial of the PP&L Petition and the maintenance of the existing procedural schedule which would require the filing of main briefs on
