

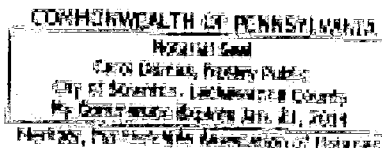

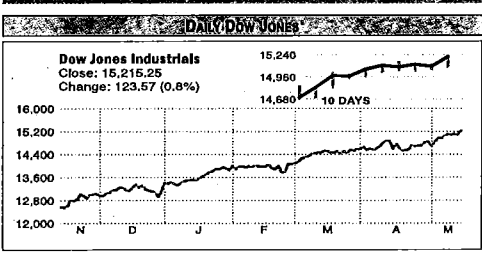

Market rises to record territory

Small business owners were slightly more optimistic in April, according to a survey released by the National Federation of Independent Business before the stock market opened. That helped push the Russell 2000, an index of small-company stocks, up 1.3 percent, ahead of other major indexes.

Public Notice Transmission Line Construction

PPL Electric Utilities Corporation (PPL Electric) plans to install a new transmission line to connect the proposed Rauch Creek Wind Farm to PPL Electric's transmission system. This project is located in Barry, Eldred, Fraley, and Hegira townships, Schuylkill County.

The new transmission line will be added to existing structures, which currently carry one PPL Electric transmission line, for approximately 6.5 miles. There will be a short section, approximately 500 feet, of new underground construction at the northern end of the project to connect the new line to PPL Electric's existing 125 foot long section of new overhead line on new structures at the southern end of the project.
