BY THE COMMISSION:

PP&L, Inc. (PP&L) by motion filed June 23, 1998 has requested additional time for submission of a compliance filing to be made in the above-captioned proceeding.

The proceeding is the PP&L restructuring case under the Electricity Generation Customer Choice and Competition Act, 66 Pa.C.S. §§2801-2812. The Commission order in that case was entered June 15, 1998. That order determined the competitive transition charge (CTC) that PP&L could collect from its customers and provided that a "shopping credit" would be available to customers who choose to purchase generation from other

sources in the future. As PP&L notes in its motion, since this is a fundamental change in the way in which electric service is provided, there were many complex issues in the case.

The order of June 15 required that PP&L make a compliance filing, making changes necessary in tariffs and addressing all other matters, within twenty days of entry of the order. Thus the compliance filing would be due on July 6, 1998. PP&L in its motion for additional time points out the extreme difficulty in making such a complex filing in this short time period. PP&L further contends there are several significant errors in the Commission order which would affect calculations necessary to the compliance filing. Although it had not yet done so when it filed this motion, PP&L asserts it is in the process of filing a petition for reconsideration which will provide detail on these alleged errors and allow correction thereof. Since resolution of the issues raised on reconsideration would affect the compliance filing, there is thus another reason beyond the complexity to delay making the compliance filing.

PP&L states it will ask the Commission to reconsider the June 15 order at our public meeting on July 9, 1998. It therefore requests that it be permitted to make its compliance filing twenty days after entry of the final Commission order on reconsideration. It asserts no party will be disadvantaged by this extension of time.

Although there is as yet no petition for reconsideration from PP&L or any other party before the Commission, it appears reasonable to grant some additional time for the submission of a compliance filing. Therefore, we afford PP&L until July 15, 1998 to


make this filing. That additional time should enable PP&L to prepare its calculations, while also ensuring that the compliance filing is not unreasonably delayed so as to effect the enrollment notifications scheduled to begin as early as August 14, 1998. If we find, in ruling on any petitions for reconsideration that may be filed in this proceeding, that additional time is warranted beyond July 15, 1998, we will so indicate at that time;
THEREFORE,

IT IS ORDERED:

1. That the motion of PP&L for additional time for submission of its compliance filing, pursuant to the requirements of the Commission order entered June 15, 1998 at Docket No. R-00973954, is granted in part, consistent with the provisions of this order.

2. That PP&L is permitted to make its compliance filing in this matter on or before July 15, 1998, subject to further extension of time if necessitated by reconsideration of the prior Commission order.
