Re: Tennessee Gas Pipeline Company, L.L.C.'s Status Under the Pennsylvania Gas and Hazardous Liquids Pipelines Act

I am writing on behalf of Tennessee Gas Pipeline Company, L.L.C. ("Tennessee"). Tennessee is in receipt of the Public Utility Commission's ("Commission") June 28, 2013 letter providing Tennessee "one final opportunity to submit its Pennsylvania Pipeline Operator Annual Registration Form" to the Pennsylvania Public Utility Commission ("Commission"). A copy of the letter is attached as Exhibit A for your reference.

Last year, Tennessee registered as a "Pipeline Operator" under the Gas and Hazardous Liquids Pipelines Act (the "Act"). See <http://www.puc.state.pa.us/pcdocs/1171222.pdf>. However, Tennessee's filing was in error, as Tennessee is not a "Pipeline Operator" under the Act. All of Tennessee's assets located in Pennsylvania are under the jurisdiction of FERC. Tennessee does not have any non-jurisdictional gathering assets in Pennsylvania. Indeed, in email correspondence last year between Tennessee and the Commission, attached as Exhibit B, the Commission's own Mr. Ralph Graeser acknowledged that Tennessee is not under the Commission's jurisdiction.

Because Tennessee is not a "Pipeline Operator" under the Act and is thus not subject to the Commission's jurisdiction—which the Commission has already acknowledged—Tennessee wishes to hereby withdraw its 2012 Annual Registration Form. Going forward, unless and until Tennessee becomes a "Pipeline Operator" under the Act, Tennessee will not be submitting, voluntarily or involuntarily, Annual Registration Forms under the Act. Tennessee respectfully requests, consistent with #13 of the Commission's published FAQ on registration under the Act, that the Commission remove Tennessee from its annual mailing list.

Dear Mr. Reji,

The purpose of this letter is to give your company one final opportunity to submit its Pennsylvania Pipeline Operator Annual Registration Form to the Pennsylvania Public Utility Commission (Commission). In accordance with the Pennsylvania Gas and Hazardous Liquids Pipeline Act, (Pipeline Act or Act 127), the Commission must develop and maintain a registry of pipeline operators within the Commonwealth of Pennsylvania. As of April 1, 2013, your company has been in violation of Act 127 because it failed to file the required Annual Registration Form along with its 2013 registration payment of \$250 and mileage report.

This matter has been referred to the Commission's Bureau of Investigation & Enforcement (I&E) for prosecution. To avoid prosecution, send an original copy of the Annual Registration Form along with attachments and filing fee to:

If your company's Annual Registration Form, mileage report and registration fee is not received within twenty (20) days from the date of this letter, I&E will institute an enforcement action that could cost your company as much as \$1,000 per violation per day from April 1, 2013 until the fee is received. Simply stated, if we receive the report and registration fee from you within 20 days, we will mark this matter closed and take no further action. On the other hand, if we do not hear from you within 20 days of the date of this letter, we will begin the enforcement proceeding.
