I am responding to the complaint of failure to maintain cargo insurance filed on July 2, 2013. Docket no. C-2013-2370215

As of April 1, 2013 I made a decision to suspend my business to help provide care for my wife who was diagnosed with cancer and undergoing treatment.

All of my Insurance policies were current at this time.
Progressive commercial insurance policy # 0557784-5 (01/07/2013 to 01/07/2014)
General Liability policy # WS118354 (10/01/2012 to 10/01/2013)
Cargo Insurance policy # PIA06644401 (04/04/2012 to 04/04/2013)
See certificate of insurance enclosed.

I paid my cargo insurance with Interstate Insurance (policy # PIA06644402) on April 2, 2013. See Coleman Insurance receipt enclosed.

April 9, 2013 was the last day of operation of the company. I have maintained my truck insurance and PA registration current to be able to move and sell the equipment. I have not used my truck for any hauling after this date.

On April 7, 2013 I was offered a job of delivery driver for PF Cook Brick Co. I took the job and started work on April 14, 2013.


Cancellation of cargo and general liability insurance was done at Coleman Insurance. I sent a cancellation letter to State Workers Insurance Fund for workers compensation Policy #04185280 on April 10, 2013.

A notice of suspension was received on 05/18/2013. I called the PUC, I was advised to send a letter explain the reason of my actions. A letter was sent on June 4, 2013 to the PUC by certified mail. A copy of this letter is enclosed.

When I suspended my business on April 9, 2013 I wanted to resume the business after my wife's health improved. After consideration of all my options I will not resume the business.

I request that my PUC authority (PUC #A-00110828) be cancelled.

On December 24, 2012 my wife was diagnosed with cancer. I was not working at this time due to no work at the brick plant and winter weather.


I made a decision in April to suspend my business to help and provide care for my wife.

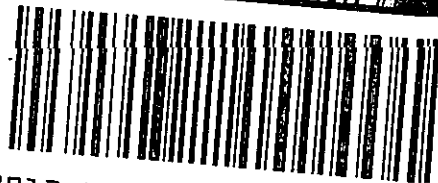

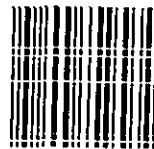
